

Amendments to the Service Level Agreement and attendant documents on grant for Limerick City of Culture

Under Section 1 paragraph 2 of the Service Level Agreement (SLA), it must be read in conjunction with

- The Heads of Agreement entered into on 6 January 2014 between the Minister and the Chief Executive of Limerick City and County Council.
- The letter of approval.

A Protocol prepared under Section 12 of the SLA, forms an Addendum to the SLA.

Under Section 1 paragraph 3 of the SLA, the Department of Arts, Heritage and the Gaeltacht (hereinafter referred to as the Department) and Limerick City Council (hereinafter referred to as the Council) agree to amend the SLA.

On signature of this documents on behalf of the Department and the Council, the Amendments listed hereunder will form part of the corpus of agreements underpinning the relationship between the parties as allowed for under this section of the SLA signed on 24 February 2014.

Amendments

Service Level Agreement (SLA)

Section 1 paragraph 7 is hereby amended by inserting €7,500,000 instead of €6,000,000.

Section 1 1) is hereby amended by replacing the words "heritage and Irish language" with the following "*heritage, Irish language and certain sporting events*"

Section 1 2) is hereby amended by replacing the figure €750,000 with €937,500.

Section 1 9) is hereby amended by inserting the figure of €1,500,000 in the December box.

Section 1 10) is hereby amended by inserting the words "at least" before the figure of €250,000.

Section ii of Key Deliverables by Limerick City Council is hereby amended by inserting the words "where relevant" after the word "accompanied".

Section xiii of Key Deliverables by Limerick City Council is hereby amended by replacing "28 February 2015" with "30 April 2015".

The Key Deliverables by Limerick City Council is hereby amended by inserting an additional indent after (xix) as follows:-

"xx *Limerick City and County Council has in place a policy in relation to the protection of vulnerable adults and a Child Protection Policy and procedures which are in*

accordance with Children First: National Guidance for the Protection and Welfare of Children."

Heads of Agreement

Section 1 of the Heads of Agreement is hereby amended by inserting €7.5 million instead of €6 million.

Section 7 is hereby amended by removing the final sentence "*In any event, the grant shall not exceed €6 million.*"

Section 8 is hereby amended with the addition of a sentence. "*Certain sporting events, may however be funded from the Department's grant.*"


Addendum
